

## **FSPR Volunteer Service/Activity Description**

### **Restoration/repair of historic properties:**

Description: Repair and restore buildings and other structures and man-made features to preserve and protect historic sites on public lands.

1. *Location:* San Pedro Riparian National Conservation Area, specific locations determined in project planning
2. *Time/schedule commitments:* Special projects planned and announced in advance, 3 to 4 hour workday or longer depending on project.
3. *Use of government vehicle:* Will be operated by government employee to haul loads to landfill. May ride as passenger in government vehicle.
4. *Use of personal vehicle:* For volunteer's personal transportation to work site.
5. *Tools and equipment:* Power tools, hammers, drills, and other construction equipment. Ground cloth, goggles, mask and hard-hat. May work near or around heavy equipment.
6. *Personal tools and equipment:* Gloves and personal protective clothes and footwear. Drinking water and food.
7. *Skills and abilities needed:* Construction and restoration techniques appropriate to historic sites and structures. Walking on natural terrain, operating power tools, use of hammers, drills, and other construction equipment. Picking up and carrying heavy or cumbersome supplies and other loads.
8. *Training and certifications:* Historic preservation methods and prior experience. Recognizing potential hazards encountered in construction sites and operating power tools. Lifting and carrying heavy loads and tools.
9. *Level of physical activity:* Moderately strenuous due to walking, picking up and carrying awkward loads.
10. *Hazards or risks:* Walking outdoors on natural terrain, uneven and rough ground, sometimes in remote locations. Potential cuts and punctures, potential pathogens, hazardous materials. Hazardous materials will be reported to BLM representative on site, and will not be handled or removed by volunteers. Encounters with stinging and biting insects, wildlife, allergens (dust, pollen). Encounters with undocumented immigrants, drug smugglers, hunters.
11. *COVID-19 preventative measures:* For volunteer work conducted, volunteers are recommended to wear a face mask either disposable (must be disposed of after volunteer work ends) or hand-washed (it is the responsibility of the volunteer to launder their own mask after use). Volunteers should have their own hand sanitizer during volunteer work due to touching objects. Volunteers should hand wash with soap and water inside BLM facilities or use hand sanitizer frequently. Any tools being used for project work should be wiped and sanitized before and after the project. It is recommended to not share tools during the project. Volunteers may use disposable gloves during their duty hours but must dispose of the gloves after volunteer work. Social distancing should be practiced at BLM facilities. If the volunteer is ill, the volunteer shall notify their supervisor and keep the supervisor informed of their health condition prior to returning to work.
